#### 1. Purpose of the process monitoring visit:

GUSS by the financial assistance of IDRF and Muslim Aid USA is being implementing the six months project to improve the Shelter condition and distributing warm cloths as NFI to the Forcibly Displaced Myanmar National (FDMN) vulnerable Rohingya Refugee families and the surrounding host community in Ukhia, Cox'sbazar. To address these pressing priorities and moving into Phase 3 of the shelter response, the SNFI Sector designed the Transitional Shelter Assistance (TSA)2, whose aim is to incrementally increase strength and durability of the shelter, as well as to provide refugees the freedom to choose the most appropriate materials and to improve shelters by themselves. By reconstructing and maintenance-- the existing Shelter, Water well, Tube well and distributing warm cloths to the Rohingya refugees and the host community nearby catchment areas, GUSS has targeted to achieve the following objectives: -

- 1. To address the protection concerns of the refugee and host communities living in Refugees Camp and catchment areas in Cox's Bazar.
- 2. To improve living condition and access to the clean drinking water for Rohingya families living in Kutupalang Refugees Camp in Bangladesh.
- 3. To building capacity in the development of sustainable operation, maintenance, improvement and fire safety of shelter and water point.

Therefore, as stated in the project proposal; the monitoring, control and evaluation of the project are the part the management of the implementing organization and in line with the interest of the donors a process monitoring is expected to be undertaken throughout the project period.

The process monitoring was to see the process documentation and execution of the various project activities, the work and results and the effectiveness of how the objectives are achieving as defined. Through this process monitoring the management could see the progress and calculate the budgetary control in line to the budget at any time, based on the time already elapsed.

The logic of the process monitoring is to facilitate to the management to organize or reorganize the project implementation strategy and or to bring any positive change in the project document. So that require steps can be undertaken in the rest of the project implementation period in order to achieve the goal and purpose of the project and expected by all stakeholders.

#### 2. The following activities were completed as part of the process monitoring visit:

I have visited the project field office for a process monitoring works of the Shelter and NFI project of GUSS at Ukhia upazila in Cox'sbazar district. The project is being implementing to build 90 shelters, 1 water well, 10 Tube wells, providing 300 shelter assistance, 1400 pcs blanket distribution in the Rohingya refugee camp and the host community in Ukhia and Cox'sbazar sadar upazila under Cox'sbazar district. The project is funded by the financial help of Muslim Aid -USA and IDRF-UK with the budget of respectively BDT. 96,60,000 and BDT. 63,81,000. The project implementation duration is Muslim Aid -USA October/2020 to March 2021 and November/2020 to April 2021 respectively.

By reviewing the objectives, stated in the project proposal it has revealed that these project is being implementing for:-

O actoress the protection concerns of the refugee and host communities living in Refugee camp and catchment areas in Cox'sbazar.



- 2. To construct 120 transitional shelters and NFIs for the Rohingya families living in the refugee's camp and host families in Ukhiya.
- 3. To building capacity in the development of sustainable operation, maintenance, improvement and fire safety of shelter.
- 4. To install 01 water well to supply clean drinking water for the refugee families living in the refugee's camp.

- b) **Review of other reports and learning documents:** Learning Shelter/NFI documents, TSA II, peer review reports, Shelter design & building technology, delivery chain and risk mapping, and Process documentation etc.



#### Major Issues that may require immediate actions recommended

From the perspective of monitoring activities, there were not found any major concerns of the MAUSA shelter project implementation against the project work plan by the implementing agency. Whereas, hands-on actions need to be taken to the IDRF project by GUSS in order to deliver the Shelter repair materials before smoothly closing its project period.

#### 1. Shelter assistance project of IDRF



- authorities have been acquired by GUSS. However, the physical activities to implement was not yet start.
  - By monitoring date, the process for the project staff hiring doesn't completed as per proposal. while the timeline of project shall be ended in mid of May 2021.
  - The beneficiaries for Shelter assistance project have not yet been selected. The PC has informed that CiC office will selected the beneficiary expectedly in 2<sup>nd</sup> week of March 2021. The beneficiary selection process should be completed immediately. while the timeline of project shall be ended in mid of May 2021.

#### 2. Tube well installation to the host community under MAUSA project:

Hold discussion among host community members to collect the information of water quality, it has revealed that one Tube well installed at Ali Ahmed, s/o Shafigur Rahman village Ali Mura Kashiar Bill, Rajapalang is delivering sedimented water. This can be re-installed to another place by February 2021.

#### 3. Project admin and accounts at Head office (MAUSA & IDRF):

From the perspective of process monitoring of the project accounting and finance department, there were some transactions have revealed those were posted and or charges wrongly those need corrective measures. Also there are some critical issues on the books of accounting and treatment those could be settled before the project shall be ended in mid-May 2021.

- 1. Separate Project bank account.
- 2. The bill payment vouchers. For example, monitoring, utilities etc.
- 3. Blanket purchase for IDRF project.
- 4. Tax and Vat posting.

#### 4. Project monitoring reports:

During project documents and records reviewing, there were no project monitoring report found at the head office. The project monitoring report is an important part of the project monitoring and tracking.

5. Project staff hiring process:

By the day of monitoring, there were no separate project staff attendance register, staff hiring documents etc found. However, Project staff and resource documents are also important to the project those need to be preserved immediately.

#### Feedback by the field staff 5.

Discussed to the field staff about project implementation challenges and experiences. The following factors have come out those are vetted during the visit. The challenges or influence the overall progress and activities.

1. Controlling shelter size and Measurement was a problem that causes the implementation slow.



- 2) House designed didn't accepted by the beneficiaries.
- 3. Windows installation are not allowed by the beneficiaries that causes delay to the work to be done.
- 4. Delayed approval process in cluster wise work.
- 5. Frequent discission changes by the CiS office.
- 6. Labor payment is a factor. Labor doesn't agree with non-cash payment process.

#### 6. Debriefing points agreed:

After completing the field visit, there was a debriefing meeting was conducted with the CEO at the head office. The overall observations of the projects have discussed prioritizing the status appended below. In regards of this GUSS management will undertake immediate actions to resolve the observations come out.

#### **Overall status:**

From the perspective of process monitoring visit, I have physically observed and reviewed the field activities of the Shelter and NFI project of GUSS at Ukhia upazila in Cox'sbazar district. There are two projects are being implementing for MAUSA and IDRF. Giving below the brief status.

As per approved documents GUSS has built 90 shelters, 1 water well for the Rohingya refugees and 10 Tube wells for the host community. At the same time GUSS has to provide 300 shelter assistance materials to reconstruct the existing shelter of Rohingya refugees by the financial assistance of IDRF and blankets to the host community. During my visit I have found 1400 blankets have been distributed to the host community in Ukhia and Cox'sbazar sadar upazila under Cox'sbazar district.

The project is funded by the financial help of Muslim Aid -USA and IDRF-UK with the budget of respectively BDT. 96,60,000 and BDT. 63,81,000. The project implementation duration is Muslim Aid -USA October/2020 to March 2021 and November/2020 to April 2021 respectively.
